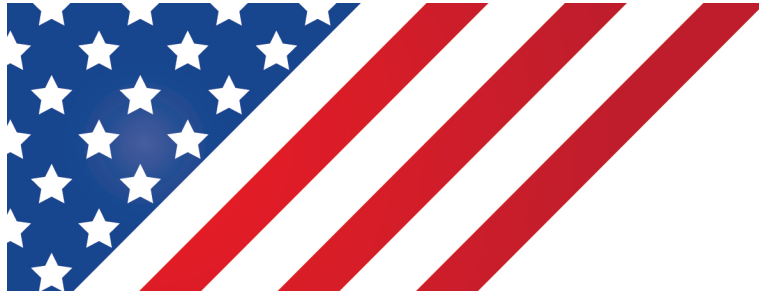

ELECTIONS IN 2017

The consolidated elections of 2017 are upon us as we prepare to elect candidates for townships, municipalities (cities and villages), and library, park and school boards. The Iroquois-Kankakee Regional school trustees and Community College trustees will also be elected. The two elections this year will be the February 28th Consolidated Primary and the April 4th Consolidated Election.

The February primary election is for the Democratic nominee for Mayor of the City of Kankakee. This will be the only race on the ballot and is open only to voters in the City of Kankakee who are declaring themselves to be a Democrat. This is projected to be an election with a low voter turnout, so some of the precincts that are partially contained in the city will be combined with other adjoining precincts. Affected voters will be notified before the election. No other polling places in the county will be open.

The April 4th Consolidated Election will be held to elect office holders for units of local government and schools. There are two public questions that will appear on the ballot initiated by the Kankakee County Board. The first question seeks to raise the sales tax by a quarter (1/4) cent for public safety. It is a binding resolution which means that, if passed, it will go into effect. The second question is advisory and will ask the voters if they wish to reduce the size of the county board.

While turnout in odd-year elections is a fraction of the presidential election, odd-year elections are of no less importance as we will elect people who determine the amount of taxes we pay, set local laws and have a great impact on our children's education.

Due to the many different ballot styles in each precinct, this is a much more complicated election than a general election in even-numbered years. Multiple ballot styles appear because of the many boundaries of the jurisdictions that overlap in each precinct. For example, a precinct may contain two or more wards. Many precincts have more than one school, park or library district whose boundaries overlap. Additionally, a precinct may have a portion of their voters living in a village where other voters are in an unincorporated area.

All precincts have more than one ballot style, and some have as many as eight ballot styles, making it very important that you be aware of the different ballots you may have. With the E-Pollbooks, however; matching each voter with his or her appropriate ballot style is easier because the ballot style number is printed on the ballot slip.

For the most part, all procedures will remain the same as the November 8, 2016 election, including registering people to vote on the E-pollbook. Two very important points to remember when registering people to vote or updating their existing registration are to please take your time to make sure the data you are entering is accurate and to **always confirm all spelling within the registration with the voter.** We did receive a few registrations where partial data was entered, or the name was not spelled correctly. For example, the last name of one voter was Stevenson, but the data was entered as Stevens. This data is being entered in the voter rolls, so accuracy is critical. Thanks for taking the extra time to make sure everything is correct!

ELECTION JUDGE REFRESHER COURSES FOR 2017

Due to the success of the November 8, 2016 elections, there will be limited but specific training offered for the February 28 and April 4 Consolidated Elections.

February 28 Election:

The February 28 Consolidated Primary Election is for the City of Kankakee Democratic primary only. There will be 12 precincts open in the city. Election review will be held **February 21st at 1:30 p.m. or February 22nd at 5:30 p.m.** Classes are at 189 E. Court St., Kankakee on the fourth floor in the County Board Room. If you need to review the touch screen or E-Pollbook, call our office and we can set up individual training for you.

April 4 Election:

A 90 minute refresher course for the April 4th election will be offered on Tuesday, March 21, at 6 p.m. or Wednesday, March 22, at 2 p.m. in the Kankakee Community College auditorium to answer the many questions that are unique to this more difficult consolidated election. We will focus particularly on answering questions regarding multiple ballot styles, a brief review of poll pads, and lessons learned from our experiences during the presidential election. This 90 minute refresher course will be useful in addressing election day issues. Each election is no less important than any other, so we will want to do our best to make sure every voter is processed efficiently and correctly. Our online training will also be available for anyone who wishes to review or revisit any portion of election classes.

Practice Makes Perfect:

Any judge who would like a refresher on E-Pollbook and/or touchscreen may contact our office at (815) 937-2990 to arrange an appointment. Appointments will be available March 16-18 and March 27-29. Training sessions last approximately 30 minutes. If you have a specific question about the E-Pollbooks, email our office at countyclerk@k3county.net and we can incorporate it into our KCC training.

NOVEMBER 8, 2016 ELECTION RECAP

Election judges in Kankakee County performed their duties admirably as a large number of citizens (73.71% of registered voters) exercised their constitutional right to vote on November 8, 2016. This turnout is typical for a presidential election. Election officials in other parts of the state also had a similar experience.

As election judges, we know the results of our precinct polling place, but often do not know how other polling locations fared. To give you an idea of results throughout the county, here are some statistics that include data from the early voting sites:

EARLY VOTING: Early voting for this election was an all time high as 12,841 people in Kankakee County cast their ballot before Election Day. Our previous high was 8,562 ballots cast during the 2012 presidential election. Almost 27% of the ballots cast in Kankakee County for the presidential election were before polls opened on November 8. That seems like a lot, but many counties around us are starting to see close to a 40% early voting turnout as political parties and campaigns make efforts to encourage this practice.

Convenience also plays a role in higher turnout for early voting. People could vote at any of the three early voting locations, regardless of where they reside within the county. Early voting sites in Manteno (Leo Hassett Building) and Bourbonnais (Community Building) were selected because they are in more populated areas with large precincts, thereby reducing crowds and long lines on Election Day. Voters in these locations cast their ballots using touch screen machines. At the County Clerk's office, voters could choose to vote using either the paper ballot or touch screen.

ELECTION DAY IN THE OFFICE: Starting eight days before Election Day, the County Clerk's office was open from 8:30 a.m. to 7 p.m. during the week. We were also open on the Saturday and Sunday before the election. The day before the election, we were in the office until 9:30 p.m. and back at it on Election Day before 5 a.m.

The closer we came to Election Day, the larger the crowds grew in the office. On November 7th, the day before the election, we had 985 people cast their ballot in the County Clerk's office.

People who were not registered to vote were allowed to register and vote through the close of the polls. Here are the numbers of people who registered and voted on Election Day by township. We also registered and voted 185 people in our office on Election Day.

ELECTION DAY IN THE POLLING PLACE:

E-Pollbooks: The E-Pollbooks were critical in the successful implementation of same day registration. Thank you for your acceptance, willingness, and skill in using this equipment. As a result of this technology, we are able to track voter activity. Every minute, from the time the polls opened at 6:00 a.m. until they closed at 7:00 p.m., someone in Kankakee County was checking in to vote. The busiest time was from 4 p.m. to 5 p.m. when nearly 3500 voters countywide checked in to vote.

County Clerk employees responded to 110 instant messages on the E-Pollbooks. We hope the instant messaging feature was a help to you and it allowed for prompt responses to answer important questions. In addition to the 110 instant messages, our office staff also answered 791 calls from election judges on Election Day.

When you consider the new laws that were implemented, the new technology that was used, and the number of different issues that we faced it is truly a strong statement when we say that Election Day in Kankakee County was a huge success. Thank you for your hard work, patience, and dedication to your ongoing service as an election judge.

February 23, 2017	Last day to receive a request for a ballot by mail

People who did not register to vote by the deadline of January 31 may register and vote through grace period registration and voting in the County Clerk's Office or precinct polling place through 7 p.m. on Election Day. Two forms of identification are required.

MULTIPLE BALLOT STYLES FOR APRIL

BALLOT STYLES -

Ballot styles are an important part of the Consolidated Election.

E-pollpads make it easier to identify the proper ballot to be issued because the ballot style number is listed on the ballot application for each voter.

Election judges must issue the ballot that corresponds to the ballot style number listed on the ballot application. See examples below:

HELPFUL HINTS FOR A SUCCESSFUL ELECTION

The following suggestions have been gathered from various people including election judges, voters and staff in an effort to keep the voting process running smoothly on Election Day.

- Assignments have gone out in the mail to judges in the Kankakee precincts for the February 28th election. Assignments for the April 4th election should go out in the mail the first or second week in March.
- If you are not working in the precinct where you are registered to vote, plan to vote before Election Day either by mail or early voting in our office.
- When you set up the day or evening before, ensure you have a safe and orderly flow for voter traffic with an adequate number of booths. E-Pollbooks must be set up in a way that avoids trip hazards. Velcro strips, special tape, and longer cords will be provided to assist with this.
- Where feasible, use tables with privacy screens for voting. This also allows you to accommodate people with disabilities and provides additional voting areas.
- After unloading your election material, park a distance away from the entrance to your polling place to allow voters easy access to enter your building.
- Be knowledgeable about different ballot styles you may or may not have in your precinct. Every ballot style is a unique combination of offices, so it is critical you issue the voter the ballot style that corresponds to the number on their ballot application.
- Always protect the secrecy of every voter's ballot by ensuring you have and use ballot privacy covers.
- If a new person is assigned to your polling place, help them along by taking time to make contact with them before Election Day and always work together as a team.
- **Everyone who is not an election judge or voter must have credentials in the polling place and sign in and out on the pollwatcher envelope.**
- Have your manuals that were given to you in November on hand in case you need to reference them.
- Update the tracking sheet at the designated times, making sure that the numbers on the optical scan and touch screen (also include any voters in the process of voting) match the number of voters checked in.
- Complete all paperwork at the end of the night.
